**Tender documents** for the above-mentioned services and goods may be obtained subsequent to each briefing session, from the reception area upon payment of the indicated non-refundable fee. Please note that only original deposit slip will be accepted as a proof for purchase of the tender document, no Electronic Transfers slips will be accepted.

**All the tenders will be evaluated in line with the preferential Procurement Policy Act, Act No 5 of 2000 in accordance with the following stages:**

**Stage 1**

**Quality and functionality:** 60 points: Experience of similar project = 15, quality and experience of key staff = 5, availability of relevant resources to deliver goods / service = 5, Trade references = 5, price = 30 [NB: Tenders not meeting 50% of quality / functionality points will be dropped and will not proceed to stage 2 which is evaluation.

**Stage 2**

**80/20**Point system will apply where 80 will be allocated for price and 20 for B-BBEE, where prices are below R1. Million thresholds.

**90/10** Point system will apply where 90 will be allocated for price and 10 for B-BBEE, where prices are above R1. Million thresholds.

Attached to the tender documents should be the following statutory supporting documents

1. Original certified copies of Identity Documents of Members/Directors/ Shareholders of the company
2. Original valid Tax Clearance certificate
3. Sanas approved Certified copy of BBBEE certificate
4. Proof of paid-up latest municipal account of the company or the owner/s

7. Certified copies of licensing/qualifications where applicable
8. Traceable references for experience purposes where applicable
9. All tender prices to be valid for 90 days
10. Black listed companies will be immediately disqualified [National Data Base for blacklisted companies]
