Phokwane Local Municipality is not bound to accept the lowest bid or award a contract to the bidder scoring the highest points. The Municipality reserves the right to partial acceptance of one or more bids, to withdraw any invitation to tender and/or to re-advertise or to reject any tender.

The provision for this chemicals will be for the following treatment plants and boreholes and post chlorination at distribution points in municipal area.

- Hartswater Water Treatment works
- Jan Kempdorp Water Treatment works
- Hartswater Waste-water works
- Jan Kempdorp waste-water works
- Magogong package plant
- Ganspan Boreholes

The following are the projected quantities that may be required during the contract period:

- 480 Chlorine gas cylinders of 70kg per annum.
- 1000 Drums of HTH of 25 kg per annum.

The bidders must comply with the following provisions:-

1. FUNCTIONALITY

DEFINITIONS : ‘Functionality’ means the measurement according to pre-determined norms as set out in the tender documents, of a service or commodity that is designed to be practical and useful, working or operating taking into account among other factors, the quality, reliability, viability and durability of a service and the technical capacity and ability of a tenderer.

Functionality Criteria

Tenderers will need to score a minimum of 70 points to be further evaluated.

2. EVALUATION PROCESS.

The tender and evaluation process for this tender will be based on the 80/20 preference procurement policy systems where 80 tender adjudication points will be awarded for functionality qualifications and price and 20 points for BBEE respectively. Tender adjudication points for performance and price will be calculated by the Employer while the points for Equity Ownership by BBEE in an enterprise will be claimed by the Tenderer.

3. DOCUMENTS TO BE SUBMITTED WITH THE BIDS (failure to submit will lead to your tender being disqualified).

1. The successful supplier must submit accredited quality control certificates e.g. MSF, ISO 9001.
2. NSF Certificated for tendered product.
2. Proof as Manufacturer or approved distributing agent for the manufacturer in terms of agent status.
3. Letter of Good Standing with COID.
4. Key personnel Assigned to the Work.
5. Proof of Liability Cover or letter of Intend to Provide Public Liability Cover.
6. Hazchem Certificate of the Driver/s.
7. Emergency Response and Environmental Management Plan.
8. Assurance of supply from the bidder's supplier or manufacturer to be submitted. (Proof to be provided)
 - e.g. (a) Tender Company is manufacturer of chemical offered.
 - (b) Distributor- Written agreement between source and the supplier.
9. Entity Registration for Transportation of Hazardous Goods.
Proof of registration for transportation of dangerous goods in accordance with relevant legislation is to be provided and delivery vehicles in terms of Reg.275 of the National Road Act 93 of 1996.

SCOPE OF WORK

The purpose of the tender is to appoint a suitably experienced and qualified polymeric chemical supplier for the supply and delivery of polymeric chemicals on as and when required basis to the municipality. The following is covered in the scope of work:

1. Ensuring that the municipality receives uninterrupted supply of HTH and Chlorine chemicals to various sites detailed in the specification.
2. Supply, delivery, offloading, stock control and assurance of performance of HTH and Chlorine chemicals to various water treatment plants in the municipality.
3. The disinfecting chemicals shall be able to produce drinking water which complies with SANS 241 quality standards.
4. Tenderer must have Quality Standard Systems e.g. **ISO 9000** and products must have "**Drink water Approval**" by accredited body e.g. NSF Accreditation Quality Standard System with maximum allowable dosing rate.
5. Delivery of the stock will be for primary business of Phokwane Municipality e.g. Hartswater and Jan Kempdorp WTW& WWTW.
6. The successful bidder / supplier has to conform to a minimum of one of the national water safety standards e.g. **NSF, USEPA, EU and WHO. Product must be certified for use in Potable Water.**
7. The tenderer shall comply with lead times and delivery times to be specified in the tender document.
8. The tenderer shall be duty bound to supply a certificate of analysis for each batch of delivery.
9. The tenderer shall use transport that complies with safety requirements for transportation of hazardous chemicals.
10. The driver must also be a certified Hazardous Chemical driver.
11. The tenderer shall comply to **The Occupational Health and Safety Act 85 of 1993, section 10(3)** and Phokwane municipality Health and Safety Specifications and provide the following:
 - a. **SHE plan**, provide the municipality with comprehensive SHE plan before commencement of work.
 - b. **Hazardous Chemical Substances Regulations 9A, 11 and 12, the GNR 1179 of August 1995.**
 - c. **General Machinery Regulation 8, Notifiable substances, SABS/SANS 10228 code of practice for the identification and classification of dangerous goods and substances.**
 - d. **SABS/SANS 10229** code of practice for the packaging of dangerous goods and safe road and rail, transportation and MSDS (material safety data sheet) must be supplied for the product.
12. The tenderer shall provide training services to Phokwane Municipality water personnel with specific training with regard to safe use and handling of HTH and Chlorine gas.
13. The tenderer shall provide a concise company profile as detailed in the tender document.
14. Letter of good standing with COID.
15. Proof of Public Liability Cover or letter of Intend of Provide Public Liability Cover.
16. The tenderer shall ensure that delivery trucks are compatible with the existing municipality equipment / systems plants holding tanks and delivery points. Any receptacles and / or vessels for containing chemicals supplied such as tankers, cylinders or drums must be delivered in Leak Proof / Undamaged containers.
17. **Safety of DWTC in Drinking Water.**

The DWTC (Drinking Water Treatment Chemical) supplied to the purchaser shall be suitable and comply in all respects with applicable SANS/BS codes and NSF prescriptions in regards to residual amounts of these chemicals, by-products and other contaminants in their formulations.
18. The tenderer shall provide the necessary qualification documents of its technical staff (**Minimum Class V Process Controller**) who will be carrying out the test and performance of the products at the various plants once monthly.

19. The tenderers must be based within the 500km radius of Phokwane Municipal area.

20. Tenderers must be BBBEE level 1 status

ELEGIBILITY CRITERIA

The standard eligibility criteria to municipal sector bids will be applicable. In addition the following conditions will be applicable and if not complied with bids will be regarded as non-responsive.

1. Approval for use in Potable Water

Tenders will only be considered if documentation is produced stating, to the satisfaction of the municipality that the use of the product in potable water has the approval of the South African Department of Health, or any other recognised and approved authority such as International bodies, the NSF. The successful bidder must be **NSF or ISO 9001** compliant.

2. Manufacturer or approved agent status.

Bidders are required to either be certified chlorine manufacturers or be approved distribution agent for the manufacturer. The relevant documentation is to be produced to the satisfaction of the municipality.

3. Entity registration for transportation of hazardous products.

Proof of registration for transportation of dangerous goods / products in accordance with relevant legislation is to be provided and registration of delivery vehicles in terms of Reg.275 of the National Road Traffic Act No 93 of 1996.

4. Quality Certification

The manufacturer is required to be certified for NSF quality management system. Proof of current certificate to be provided. (ISO 9001)

5. Public Liability Cover

Provision of Public Liability Insurance to the value of R10M or a letter of intent from an approved insurance provider.

6. Hazchem Certification of driver

All drivers are required to be Hazchem certified and proof thereof to be provided.

7. Emergency Response and Environmental Management Plan

The supplier must ensure that an emergency plan in case of unforeseen events during the transportation and delivery of the DWTC (Drinking Water Treatment Chemical), particularly driver training in this regard, communication, first responders, fire and spill control, decontamination, recovery, rehabilitation and incident reporting and investigation.

8. Letter of Good Standing with COID

9. Training

It is required of the successful bidder to provide training material and lectures for Phokwane Municipal staff with specific regard to the safe use, handling of polymeric chemicals and optimisation with automatic dosing equipment.

Training courses are to be hosted at municipal premises. A maximum of one training course is required per calendar year for approximately 20 delegates per course. The required wall charts and Hazchem labels must also be supplied by the successful bidder on a free of charge basis to Phokwane municipality. Proof in the form of a certificate must be provided to each delegate for the necessary training received.

10. Assurance of Supply.

Assurance of supply from the bidder's supplier or manufacturer is required.

Proof to be provided.

e.g. 1. Tender Company is manufacturer of chemical offered.

2. Distributor –Written agreement between source and supplier.

11. All tendered chemicals must comply with relevant SABS / NSF quality standards. Relevant document to be provided.

Failure to provide or comply with any of the above may result in your bid being disqualified.

PHOKWANE LOCAL MUNICIPALITY TENDER CONDITIONS AND INFORMATION

1. General and special conditions of contract

The general conditions of contract (GCC) as well as special conditions of contract (SCC) forming part of this set of tender documents will be applicable to this tender in addition to the conditions of tender. Where the GCC and SCC are in conflict with one another, the stipulations of the SCC will prevail.

2. Acceptance or Rejection of a tender

The municipality reserves the right to withdraw any invitation to tender and/or to re-advertise or to reject any tender or to accept part of it. The municipality does not bind itself to accepting the lowest tender or the tender scoring the highest points. The municipality reserves the right to waive any requirements as contained in the bid conditions and or specifications.

3. Validity Period

Bids shall remain valid for ninety (90) days after the tender closure date.

4. VAT

Price(s) quoted must be firm and must be inclusive of VAT.

5. Registration on central supplier database

It is expected of all prospective service providers who are not yet registered on the central supplier database to register without delay on the prescribed form. The municipality reserves the right not to award tenders to prospective suppliers who are not registered on the database.

6. Completion of Tender Documents

- a) The original tender document must be completed fully in black ink and signed by the authorised signatory to validate the tender. Failure to do so will result in the disqualification of the tender.
- b) Tender documents may not be retyped. Retyped documents will result in the disqualification of the tender.
- c) The complete original tender document must be returned. Missing pages will result in the disqualification of the tender.
- d) No unauthorised alteration of this set of tender documents will be allowed. Any unauthorised alteration will disqualify the tender automatically. Any ambiguity has to be cleared with contact person for the tender before the tender closure.

7. Compulsory Documentation

7.1 Tax Clearance Certificate

- a) A copy of a Tax Compliance Status Pin or a Tax Compliance Certificate, printed from the South African Revenue Service (SARS) website, must accompany the bid documents. The onus is on the bidder to ensure that their tax matters with SARS are in order.
- b) In the case of a Consortium/Joint Venture every member must submit a separate Tax Compliance Status Pin and a Tax Compliance Certificate, printed from the SARS website, with the bid documents.
- c) If a bid is not supported by a Tax Compliance Status Pin and a Tax Compliance Certificate as an attachment to the bid documents, the Municipality reserves the right to obtain such documents after the closing date to verify that the bidder's tax matters are in order. If no such document can be obtained within a period as specified by the Municipality, the bid will be disqualified.
- d) The Tax Compliance Status Pin will be verified by the Municipality on the SARS website.

7.2 Municipal Rates, Taxes and Charges

- a) A copy of the bidder's (in the name of the company and/or lease agreement) and / or those of its directors municipal accounts (for the Municipality where the bidder pays his account) for the month preceding the tender closure date must accompany the tender documents. If such a copy does not accompany the bid document of the successful bidder, the Municipality reserves the right to obtain such documents after the closing date to verify that their municipal accounts are in order.
- b) Any bidder which is or whose directors are in arrears with their municipal rates and taxes or municipal charges due to any Municipality or any of its entities for more than three months and have not made an arrangement for settlement of same before the bid closure date will be unsuccessful.

- c) If a bidder rents their premises, proof must be submitted that the rental includes their municipal rates and taxes or municipal charges and that their rent is not in arrears.
- d) In the event of residing at the rural area where services are not rendered a letter from the tribal authority with affidavit must be submitted.
- e) Must be current municipal account.

8. Compulsory statutory supporting documents

- a) Certified copies of Identity Documents of members / shareholders / directors of the company (original stamp not older than 3 months).
- b) Valid CIPC documents / copies of company registration documents.
- c) Declaration of interest forms duly completed (MBD documents).
- d) General conditions of contract must be properly signed.
- e) Local content documents to be complete (when applicable)

9. Conditions

Comply with conditions as specified in the Bid documents and / or specification documents.

10. Quotation

- a) Specifications must be disclosed on the quotation.
- b) Quotation must be original and must be on the company's letterhead.

11. Site / Information Meetings

- a) Site or information meetings, if specified, are compulsory. Bids will not be accepted from bidders who have not attended compulsory site or information meetings.

12. Samples

Samples, if requested, are to be provided to the Municipality with the tender document or as stipulated.

13. Quantities of Specific Items

If tenders are called for a specific number of items, the Municipality reserves the right to change the number of such items to be higher or lower. The successful bidder will then be given an opportunity to evaluate the new scenario and inform the Municipality if it is acceptable. If the successful bidder does not accept the new scenario, it will be offered to the second-placed bidder. The process will be continued to the Municipality's satisfaction.

14. Submission of Tender

- a) The tender must be placed in a sealed envelope, or envelopes when the two-envelope system is specified, clearly marked with the tender number, title as well as closing date and time and placed in the tender box at **Phokwane Local Municipality's Main Building, 24 Hertzog street, Hartswater by not later than 12:00 on the date of closing of the tender.**

OR

- be mailed to reach the Tender Box, Phokwane Local Municipality, Private Bag X3, Hartswater, 8570 before the specified closing date and time.

- b) Faxed, e-mailed and late tenders will not be accepted. Tenders may be delivered by hand, by courier, or posted at the bidder's risk and must be received by the deadline stated on the advert, irrespective of how they are sent or delivered.

15. Expenses Incurred in Preparation of Tender

The Municipality shall not be liable for any expenses incurred in the preparation and submission of the tender.

16. Contact with Municipality after Tender Closure Date

Bidders shall not contact Phokwane Local Municipality on any matter relating to their bid from the time of the opening of the bid to the time the contract is awarded. If a bidder wishes to bring additional information to the attention of Phokwane Local Municipality, it should do so in writing. Any effort by the firm to influence Phokwane Local Municipality in the bid evaluation, bid comparison or contract award decisions may result in the rejection of the bid.

17. Opening, Recording and Publications of Tenders Received

- a) Tenders will be opened on the closing date immediately after the closing time specified in the tender documents. If requested by any bidder present, the names of the bidders, and if practical, the total amount of each bid and of any alternative bids will be read out aloud.
- b) Details of tenders received in time will be recorded in a register which is open to public inspection.
- c) Faxed, e-mailed and late tenders will not be accepted.

18. Evaluation of Tenders

Tenders will be evaluated in terms of their responsiveness to the tender specifications and requirements as well as such additional criteria as set out in this set of tender documents.

19. Procurement Policy

Bids will be evaluation in terms of the 80 (price) /20 (B-BBEE status) preferential point system. Bids will be awarded in accordance with the Preferential Procurement Regulations, 2001 pertaining to the Preferential Procurement Policy Framework Act, No 5 of 2000 and its amendments as well as the Municipality's Supply Chain Management Policy.

20. Contract

The Municipality, at its discretion, may request the signing of an additional Service Level Agreement which, together with the signed tender document, will constitute the full agreement between the Municipality and the successful bidder.

21. Subcontracting

- a) The service provider shall not subcontract the whole of the Contract.
- b) Except where otherwise provided by the service provider, the service provider shall not subcontract any part of the Contract without the prior written consent of the Municipality, which consent shall not be unreasonably withheld.
- c) The contractual relationship between the service provider and any subcontractors selected by the service provider in consultation with the Municipality in accordance with the requirements of and a procedure contained within the Scope of Work, shall be the same as if the service provider had appointed the subcontractor in terms of paragraph (b) above.
- d) Any consent granted in accordance with paragraph (b) or appointment of a subcontractor in accordance with paragraph (c) shall not imply a contract between the Municipality and the subcontractor, or a responsibility or liability on the part of the Municipality to the subcontractor and shall not relieve the serviceprovider from any liability or obligation under the Contract and he shall be liable for the acts, defaults and neglects of any subcontractor, his agents or employees as fully as if they were the acts, defaults or neglects of the service provider, his agents or employees.

22. Language of Service Provider

The contract documents will be compiled in English and the English versions of all referred documents will be taken as applicable.

23. Extension of Contract

The contract with the successful bidder may be extended on the basis of performance with a period not exceeding 15% of the original contract.

24. Wrong Information Furnished

Where a contract has been awarded on the strength of the information furnished by the bidder which, after the conclusion of the relevant agreement, is proved to have been incorrect, the Municipality may, in addition to any other legal remedy it may have, recover from the contractor all costs, losses or damages incurred or sustained by the Municipality as a result of the award of the contract.

25. Past Practices

- a) The bid of any bidder may be rejected if that bidder or any of its directors have abused the municipality's supply chain management system or committed any improper conduct in relation to such system.
- b) The bid of any bidder may be rejected if it is or has been found that that bidder or any of its directors influenced or tried to influence any official or councillor with this or any past tender.
- c) The bid of any bidder may be rejected if it is or has been found that that bidder or any of its directors offered, promised or granted any official or any of his/her close family members, partners or associates any reward, gift, favour, hospitality or any other benefit in any improper way, with this or any past tender.

26. Validity of BEE certificates:

- a) **If the certificate was issued by a verification agency the following must be on the face of the certificate:** SANAS logo, unique BVA number, must be an original certificate or certified copy of the original, the name and physical location of the bidder, the registration number and, where applicable, the VAT number of the bidder, the date of issue and date of expiry of the certificate, the certificate number for identification and reference, the scorecard that was used (for example EME, QSE or Generic), the name and / or logo of the Verification Agency, the certificate must be signed by the authorized person from the Verification Agency and the B-BBEE Status Level of Contribution obtained by the bidder.

b) If the certificate was issued by registered auditors approved by IRBA

General Conditions of Contract

1. Definitions

1. The following terms shall be interpreted as indicated:
 - 1.1 "Closing time" means the date and hour specified in the bidding documents for the receipt of bids.
 - 1.2 "Contract" means the written agreement entered into between the purchaser and the supplier, as recorded in the contract form signed by the parties, including all attachments and appendices thereto and all documents incorporated by reference therein.
 - 1.3 "Contract price" means the price payable to the supplier under the contract for the full and proper performance of his contractual obligations.
 - 1.4 "Corrupt practice" means the offering, giving, receiving, or soliciting of anything of value to influence the action of a public official in the procurement process or in contract execution.
 - 1.5 "Countervailing duties" are imposed in cases where an enterprise abroad is subsidized by its government and encouraged to market its products internationally.
 - 1.6 "Country of origin" means the place where the goods were mined, grown or produced or from which the services are supplied. Goods are produced when, through manufacturing, processing or substantial and major assembly of components, a commercially recognized new product results that is substantially different in basic characteristics or in purpose or utility from its components.
 - 1.7 "Day" means calendar day.
 - 1.8 "Delivery" means delivery in compliance of the conditions of the contract or order.
 - 1.9 "Delivery ex stock" means immediate delivery directly from stock actually on hand.
 - 1.10 "Delivery into consignees store or to his site" means delivered and unloaded in the specified store or depot or on the specified site in compliance with the conditions of the contract or order, the supplier bearing all risks and charges involved until the supplies are so delivered and a valid receipt is obtained.
 - 1.11 "Dumping" occurs when a private enterprise abroad market its goods on own initiative in the RSA at lower prices than that of the country of origin and which have the potential to harm the local industries in the RSA.
 - 1.12 "Force majeure" means an event beyond the control of the supplier and not involving the supplier's fault or negligence and not foreseeable. Such events may include, but is not restricted to, acts of the purchaser in its sovereign capacity, wars or revolutions, fires, floods, epidemics, quarantine restrictions and freight embargoes.
 - 1.13 "Fraudulent practice" means a misrepresentation of facts in order to influence a procurement process or the execution of a contract to the detriment of any bidder, and includes collusive practice among bidders (prior to or after bid submission) designed to establish bid prices at artificial non-competitive levels and to deprive the bidder of the benefits of free and open competition.
 - 1.14 "GCC" means the General Conditions of Contract.
 - 1.15 "Goods" means all of the equipment, machinery, and/or other materials that the supplier is required to supply to the purchaser under the contract.

12. Transportation	12.1 Should a price other than an all-inclusive delivered price be required, this shall be specified in the SCC.

20. Subcontracts	20.1 The supplier shall notify the purchaser in writing of all subcontracts awarded under this contracts if not already specified in the bid. Such notification, in the original bid or later, shall not relieve the supplier from any liability or obligation under the contract.
21. Delays in the supplier's performance	<p>21.1 Delivery of the goods and performance of services shall be made by the supplier in accordance with the time schedule prescribed by the purchaser in the contract.</p> <p>21.2 If at any time during performance of the contract, the supplier or its subcontractor(s) should encounter conditions impeding timely delivery of the goods and performance of services, the supplier shall promptly notify the purchaser in writing of the fact of the delay, its likely duration and its cause(s). 29. Governing language	29.1 The contract shall be written in English. All correspondence and other documents pertaining to the contract that is exchanged by the parties shall also be written in English.
30. Applicable law	30.1 The contract shall be interpreted in accordance with South African laws, unless otherwise specified in SCC.
31. Notices	<p>31.1 Every written acceptance of a bid shall be posted to the supplier concerned by registered or certified mail and any other notice to him shall be posted by ordinary mail to the address furnished in his bid or to the address notified later by him in writing and such posting shall be deemed to be proper service of such notice.</p> <p>31.2 The time mentioned in the contract documents for performing any act after such aforesaid notice has been given, shall be reckoned from the date of posting of such notice.</p>

2.1 Introduction	<p>This guideline provides tenderers with a detailed description of how to calculate local content of products (goods, services and works) by components/material/services and enables them to keep an updated record for verification requirements as per the SATS 1286:2011 Annexure A and B.</p> <p>The guideline consists of two parts, namely:</p> <ul style="list-style-type: none"> • a written guideline; and • three declarations that must be completed: <ul style="list-style-type: none"> – Declaration C: “Local Content Declaration – Summary Schedule” (see Annexure C); – Declaration D: “Imported Content Declaration – Supporting Schedule to Annex C” (see Annexure D); and – Declaration E: “Local Content Declaration – Supporting Schedule to Annex C” (see Annexure E). <p>The guidelines and declarations should be used by tenderers when preparing a tender. A tenderer must complete Declarations D and E, and consolidate the information on Declaration C.</p> <p>Annexure C must be submitted with the tender by the closing date and time as determined by the Tender Authority. The Tender Authority reserves the right to request that Declarations D and E also be submitted.</p> <p>If the tender is successful, the tenderer must continuously update Declarations C, D and E with actual values for the duration of the contract.</p> <p>NOTE: Annexure A is a note to the purchaser in SATS 1286:2011; and Annexure B is the Local Content Declaration IN SATS 1286:2011.</p>
2.2 What is local content	<p>According to SATS 1286:2011, the local content of a product is the tender price less the value of imported content, expressed as a percentage. It is, therefore, necessary to first compute the imported value of a product to determine the local content of a product.</p>
2.3 Categories: Imported and Local Content	<p>The tenderer must differentiate between imported content and local content.</p> <p>Imported content of a product by components/material/services is separated into two categories, namely:</p> <ul style="list-style-type: none"> • products imported directly by the tenderer; and • products imported by a third party and supplied to the tenderer.
2.3.1. Imported Content	<p>Identify the imported content, if any, by value for products by component/material/services. In the case of components/materials/services sourced from a South African manufacturer, agent, supplier or subcontractor (i.e. third party), obtain that information and Declaration D from the third party.</p> <p>Calculate the imported content of components/materials/services to be used in the manufacture of the total quantity of the products for which the tender is to be submitted.</p> <p>As stated in clause 3.2.4 of SATS 1286:2011: “If information on the origin of components, parts or materials is not available, it will be deemed to be imported content.”</p> <p>2.3.1.1. Imported directly by the tenderer:</p> <p style="padding-left: 40px;">When the tenderer import products directly, the onus is on the tenderer to provide evidence of any components/materials/services that were procured from a non-domestic source. The evidence should be verifiable and pertain to the tender as a whole. Typical evidence will include commercial invoices, bills of entry, etc.</p> <p style="padding-left: 40px;">When the tenderer procures imported services such as project management, design, testing, marketing, etc and makes royalty and lease payments, such payments relating to the tender must be included when calculating imported content.</p>

Imported by a third party and supplied to the tenderer:</p> <p>When the tenderer supplies components/material/services that are imported by any third party (for example, a domestic manufacturer, agent, supplier or subcontractor in the supply chain), the onus is on the tenderer to obtain verifiable evidence from the third party.</p> <p>The tenderer must obtain Declaration D from all third parties for the related tender. The third party must be requested by the tenderer to continuously update Declaration D.
